



General terms and conditions of subscription to the electronic version of Vie & Milieu

Article 1. SUBSCRIPTION AND CONDITIONS OF ACCESS TO THE ONLINE JOURNAL

The purpose of the subscription is to make available the publication "Life and Environment Vie et Milieu" hereinafter referred to as "the ReviewJournal" in digital version.

Any access to the online review journal implies full acceptance of these general terms and conditions of subscription under the conditions listed below.

1.1 Authorized Subscribers, hereinafter referred to as "Subscriber" or "Subscribers"

Individual subscriber: Any natural person of full age and with the capacity to contract who has subscribed in his own name.

Institutional Subscriber: Any legal entity that has subscribed totaken a subscription.

1.2 Subscription conditions

Subscriptions to the Journal Review are valid for one calendar year.

The subscription to the Journal Review comes into effect upon receipt of the payment made by the Subscriber.

1.3 Rates and payment terms

The subscription prices are established in Euros all taxes included. The prices invoiced to the Subscriber are those in force effect on the Journal's website dedicated to the Review on the day the order is placed.

All orders will be invoiced and payable in euros. Payment is made in cash upon receipt of the invoice sent to the Subscriber.

Article 2. SUBSCRIBED PRODUCT

The subscription entitles the Subscriber (and Authorized Users as defined in 4.1) to access the digital version of the Journal Review for which an annual subscription has been subscribedtaken, as well as reviews issues from previous years (from 2003).

Article 3. CONDITIONS OF ACCESS TO THE ONLINE JOURNAL

3.1 Authentication

Access to the subscribed products is authenticated by using the Internet Protocol (IP) addresses indicated by the Subscriber at the time of subscription.

3.2 Access to subscribed products

The subscribed products are made available to the Subscriber and Authorized Users using their format in usage on the Internet usage format, namely in PDF (Portable

Document Format), from the Internet address <http://www.php.obs-banyuls.fr/Viemilieu>.

3.3 Quality of service

Sorbonne Université, as a broadcaster, will make reasonable efforts to ensure that the Subscriber has access to the Review and to restore access to the Subscribed Products as soon as possible in the event of an interruption or suspension of service.

3.4 Removal of content

Sorbonne Université reserves the right to remove from subscriptions any content for which it may no longer hold publication rights, or for which it may have reasonable grounds to believe that it is illegal, harmful, false or infringing.

Article 4. LICENSE TO USE THE ONLINE JOURNAL

This license is intended to govern the conditions under which the Subscriber (and Authorized Users as defined in 4.1) may use the online JournalReview. The Subscriber shall take all measures towards its Authorized Users to ensure compliance with the terms hereof.

4.1 Authorized Users according to the Subscriber's status, hereinafter referred to as "Authorized User".

- Staff members employed by the Institutional Subscriber.
- Members of the Institutional Subscriber's faculty.
- Researchers from the institutional Subscriber's laboratories.
Students of the Institutional Subscriber.
-
- Third parties consulting the Review online from computer terminals made available to them in the Institutional Subscriber's libraries.

4.2 Authorized uses

Each Subscriber and Authorized User may:

- access, consult, browse and view the Journal Review online;
- print, make electronic copies and store individualized elements from the Subscribed Products, exclusively for the personal use of such Subscriber or Authorized User;
- provide hard copies or electronic copies of individualized items from the subscribed Journal Review to other Authorized Users and third party colleagues for their own teaching or research needs;

Any other use, compilation, copying or publication of all or part of the content of the publications, in any medium whatsoever, is subject to the prior authorisation of Sorbonne Université.

The author of an article may place it in an open archive.

4.3 Restrictions on the use of the JournalReview

The Subscriber acknowledges that he has no ownership rights over the content of the publications as a result of his right of access to the electronic version of the JournalReview.

Except as expressly provided herein, the Subscriber and its Authorized Users may cannot:

- reduce, modify, adapt, translate or create any derivative work issued from the Subscribed Products;
- remove, obscure or modify in any way any mention of author and copyright;
- reproduce, preserve or redistribute in a systematic or substantial manner, the Subscribed Products;
- use any robots or automated download programs, algorithms or devices that allow, in a continuous and automatic manner, to search, retrieve or extract all or part of the Subscribed Products;

4.4 Protection against unauthorized use and access

The Subscriber shall use reasonable efforts to limit the access to the Journal Review only to Authorized Users.

If the Subscriber notices any use of the Subscribed Products or access to them contrary to the provisions hereof, he shall inform Sorbonne Université and shall take all measures in his power to suspend the access from which the unauthorized use appeared. The Subscriber shall not be liable for any unauthorized use of the Journal Review by any Authorized User, provided that the unauthorized use did not result from the Subscriber's own negligence or intentional breach by the Subscriber of the terms and conditions contained herein.

4.5 Archiving

Subscriber may make one (1) electronic copy of the Journals for archiving purposes, as well as one (1) printed copy, with the exception of articles to which Subscriber has never subscribed and to which Licensor gives him free access as part of his annual subscription.

4.6 Duration of the license

This license shall have the same term as the subscription (including renewals) purchased, subject to payment of the subscription fee on expiry.

Article 5. RESPECT FOR THE PROTECTION OF PERSONAL DATA

In accordance with the French Data Protection Act, the Subscriber has the right to access, modify, rectify and delete data concerning him/her collected as part of the subscription to the Journal Review. He can exercise this right at vimilieu@obs-banyuls.fr.

Article 6. MISCELLANEOUS

Sorbonne Université may suspend or terminate this Agreement if the Subscriber or any of its Authorized Users fails to comply with any of the terms and conditions hereof.

These general terms and conditions and license are subject to French law and any dispute relating to their execution or termination shall be submitted to the competent French courts.
